

**Channel 7**  
**Big Brother KFC Spot the Bucket Competition**  
**Terms and Conditions**

**By entering “Big Brother KFC Spot the Bucket Competition” (“the Competition”), you are agreeing to the following Terms and Conditions:**

**1. STANDARD TERMS**

1.1 Information on how to enter forms part of the terms and conditions (“**Terms and Conditions**”). Participation in this Competition is deemed acceptance of these Terms and Conditions.

**2. WHO CAN ENTER?**

2.1 Subject to clause 2.2 and 2.3, entry is open to all residents of Australia aged 14 and above, where the Channel Seven (and affiliates) signal is received.

2.2 Entrants aged over 14 but under 18 years must have parental/guardian approval to enter and the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.

2.3 Employees and their immediate friends and families of the Seven Network (Operations) Limited, Kentucky Fried Chicken (KFC) Pty Ltd, Ansible Pty Ltd, and their associated agencies and companies are not eligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

**3. HOW TO ENTER**

3.1 The Competition commences on **Monday 24<sup>th</sup> May 2021 at 19:30 AEST** and concludes on **Friday 4<sup>th</sup> June 2021 at 23:59 AEST** (“the **Competition Period**”) however, the eligible registration period for each Major Prize Draw will commence and conclude on the following dates and times:

3.2 For clarification, all entrants who enter during the Competition Period will be entered into the Major Prize Draw corresponding with the registration period in which they entered.

3.3 To enter, viewers must watch Big Brother (“the **Program**”) on the Seven Network (“the **Network**”), throughout the Competition Period. There will be multiple competition segments aired during the episodes of the Program in the Competition Period, which will display information on how to enter the Competition, the valid codeword for that registration period and the SMS number. Each entrant must enter into the competition with the valid codeword within the registration period.

3.4 Entries do not carry over between registration periods. Entrants must submit an entry within a registration period, stipulated in the table in clause 3.1, to be in the running for the corresponding Major Prize Draw. For clarity the registration period between 00:00 AEST on Saturday 29<sup>th</sup> May 2021 to 19:29 AEST on Monday 31<sup>st</sup> May 2021 will be a closed period and entries shall not be accepted.

- 3.6 All entrants who have submitted an entry in accordance with clause 3.5 will receive a bounceback SMS confirming their entry into the competition along with a link to the KFC app or to download the KFC app.
- 3.7 Single SMS entries within 160 characters will be charged at the premium rate of \$0.55 (including GST). Extra charges will apply to entries exceeding this character limit. 'Characters' refers to text only. Images, emojis and/or special characters may exceed this character limit and generate additional charges. Ansible Pty Ltd Helpline is 1300 851 419. Note that premium rate services are not available via every provider, it is recommended that viewers contact their individual service provider to confirm if they have premium service access. SMS entrants under 18 years old must obtain account holder's consent.
- 3.8 Entrants may enter the competition as many times as they like, however each winner is eligible to win one (1) Major Prize for the entire competition period (excluding any SA entrants).
- 3.9 Entries must be received by the date and times stated in clause 3.1. The time of entry will in each case be the time the SMS message and/or smartphone entry is received by the Ansible Pty Ltd database. SMS entries via the internet or computer generation are invalid and will not be accepted.

Total maximum prize pool value for the prize is up to **\$30,000.00** (including GST).

- 4.3 In accepting a prize, the winner agrees to participate in and co-operate with all reasonable media editorial requests, including but not limited to, being interviewed and photographed, and the winner grants the Promoter a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide and the winner will not be entitled to any fee for such use.
- 4.4 Winners agree they will not sell or otherwise provide their story and/or photographs to any media or other organisation.

- 5.3 The first valid entry drawn in each Major Prize Draw will win a Major Prize, detailed in clause 4.2.

- 5.7 The Promoter’s decision is final and the Promoter will not enter into correspondence regarding the result.
- 5.8 The Promoter may in its absolute discretion deem entries invalid subsequently to a winner being notified or a winner’s name being announced if it is discovered that the winner did not enter the Competition in accordance with these Terms and Conditions. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
- 6.2 Incomplete or indecipherable entries will be deemed invalid.
